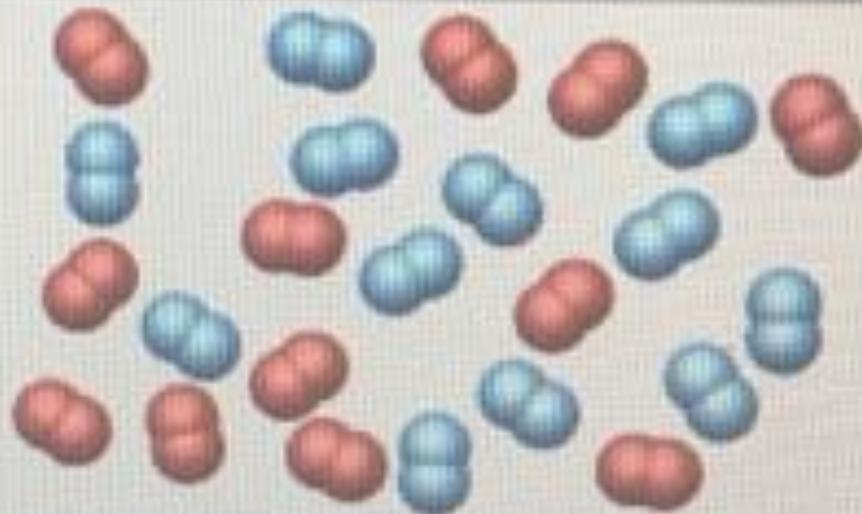

## **Is the declaration mandatory?**

Yes. The declaration is a prerequisite to be able to keep on selling products in regions that will be affected by regulations concerning flame retardants (FR). As these regulations are upcoming increasingly all over the world, BSH has made declarations on flame retardants – specifically brominated flame retardants – a global minimum requirement. Thus, as a supplier to BSH we depend on the information on your supplies to do so. In consequence, if we do not have the necessary information on the day of the legal deadline latest, this may result in reduction or stop of business. ## **How can I protect my Intellectual Property when declaring?**

The provided template is asking only for the type of flame retardant (FR) used and the corresponding polymer type in which the FR is used (codes acc. to ISO 1043). Providing further substance information (substance name, substance identifier) is optional. It is not required to make a full material declaration or otherwise communicate IP-relevant data. Likewise, we will not forward your data to outside business. The intention for us to know is for facilitating phase-out activities and for the official authorities asking to proof the BSH compliance with the regulations.

## **What to do, if I do not have all required information within the deadline?**

We are aware, that it may take some time to get the information from your own supply chain. If for some material codes you can not send us the information within the deadline, please do not just send nothing. Please mark the goods you are not yet able to give information correspondingly and send back the template to us. Should you require assistance, do not hesitate to ask.

## **Do I have to provide analytical tests, too?**

No. If test reports would be required, we would explicitly state that; as well what they need to contain and how you should provide them to us.

## **What happens, if I declare something wrong?**

This depends on the question if you have been providing false information by mistake or intentionally. In general, liability and consequences are identical to similar cases of providing wrong technical information on a product to a customer (e.g. wrong datasheets).

## **How often do I have to update my declaration?**

As long as the legal regulations remain unchanged, you only have to re-declare, if the declaration status of your products changes, e.g. by material change, design changes, etc.. In case of a change of the legal regulations, of course, there must be a new declaration according to the new regulation.

## **I do not sell a certain material anymore to BSH - do I still have to declare?**

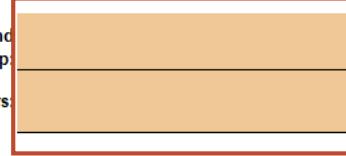
Yes, as long as BSH is using a certain product, the obligation to provide information on its legal properties exist.

# FAQs – Filling the template

## *Confirmation*

The whole filled in excel file needs to be sent back in **excel** format.

A signature is required on the *Confirmation* sheet. The signed *Confirmation* sheet of the template needs to be sent back **as pdf** in addition.

# FAQs – Filling the template

## Flame Retardants

The fields *BSH material number, SKU or Order Code* as well as the corresponding *product description* are prefilled.

For this request **intentionally added** means:

- generally that the substance has a functional or technical effect in the product
- for electronic components that the limit values for halogens (bromine and chlorine) acc. to JS 709C and IEC 61249-2-21 are exceeded due to usage of halogenated flame retardants



Also absence of flame retardants needs to be declared by selecting „No“.

If flame retardants are contained („Yes“), please proceed as described in the following steps  
(optional for electronic components).

## *Flame Retardants*

### **Step 1**

For each material number that contains a flame retarded material, provide via drop-down selection

- ***the polymer type acc. to ISO 1043-1***  
and
- ***code of contained flame retardant used acc. to ISO 1043-4***

Several entries per material code may be required for complex parts that contain several flame retarded materials.

# FAQs – Filling the template

## Flame Retardants

### Step 2

For a material number or SKU, where a material containing a flame retardant was declared, please provide

- *in case of components and parts* → amount of substance per unit as **absolute value [mg]**  
**or**
- *in case of bulk material*, e.g. resins → amount of substance as **concentration [%]**

**CAS no.** and **substance name** can be provided in addition (optional). This information will only be processed internally. Only in case of legal obligations, e.g. reporting duties, it may be reported to externals.
