

ODM Data Collection

- how to provide the data -

The data shall be provided using two different Excel templates that must not be changed in order to allow semi-automated upload by BSH. Therefore the column headlines are protected. Text entries shall be made using Latin letters and must not be formatted (bold, italics, striked through, ...).

In case, a specific entry is not possible/available, please leave the field empty and do not use "n.a." or similar.

How to use the:

1. AVL Template (Approved-Vendor-List)

AVL : Approved Vendor List of a PCBA

Each Component-Order Code-Manufacturer combination must be inserted in a separate line, thus being able to recognize the quota of each component.

Please fill in the AVL of the project line after line until a new BSH_SAP_Material_Number starts and then fill in for the next project directly below.

Naming convention of the file to be returned to BSH:

ODM_BOM_AVL_**ODM_ID**_**Export_Date**.xls

Please change the following parts of the syntax:

ODM_ID

Export_Date

Example

Explanation of the data input fields of the Excel template:

Column	field name	explanation
A	BSH_ODM_Supplier	(Full) Name of the ODM Supplier in BSH system
B	BSH_ODM_ID	ID (supplier number) of the ODM Supplier in BSH system
C	ODM_Export_Date	Date when data is exported by ODM
D	BSH_SAP_Material_Number	Material number of the purchased good (PCBA or PCBA incl. SW or PCBA incl. SW and mechanical parts, ...) in BSH system. It can consist of more than one PCBA. This number has 10 digits and starts either with 5 or 8 or 9

E	BSH_SAP_Material_Name	Material name (designation) of the purchased good (PCBA or PCBA incl. SW or PCBA incl. SW and mechanical parts, ...) in BSH system
F	BSH_PCBA_SAP_Material_Number	Material number of the purchased PCBA (may have a different number than the purchased good) in BSH system. This number has 10 digits and starts either with 5, 8 or 9. If the BSH_SAP_Material_Number and the BSH_PCBA_Material_Number are identical (possible), please leave the column BSH_PCBA_SAP_Material_Number open
G	BSH_PCBA_SAP_Material_Name	Material name (designation) of the PCBA (has a different name than the purchased good) in BSH system
H	ODM_Material_Number	Material number of delivered good (PCBA or PCBA incl. SW or PCBA incl. SW and mechanical parts) in ODM system
I	ODM_Material_Name	Material name of delivered good (PCBA or PCBA incl. SW or PCBA incl. SW and mechanical parts) in ODM system
J	BOM_Pos_Number	Position number of component in approved-vendor-list (~bill-of-material) of ODM. Follows a 4-digit formatting starting from 0010 and is incremented by 10
K	CADREF	CAD reference of component in approved-vendor-list (~bill-of-material) of ODM
L	ODM_Component_Number	(Material) number of component in approved-vendor-list of ODM
M	ODM_Component_Name	Name of component in approved-vendor-list of ODM. Maximum 128 characters
N	BSH_Component_Material_Number	if available: material number at BSH of the component
O	Quantity	Quantity used of the component in approved-vendor-list of ODM with reference to 1 pc of BSH_SAP_Material_Number. Values like 0.5 PC are not accepted.

P	UoM	Unit of measure. The accepted values for UoM are PC, PCS, KG, G, and M
Q	Quota	Quota (delivery share) of the specific order code
R	Manufacturer_ID	ID of the component manufacturer in ODM system. In case of supply via distribution and if manufacturer ID is not used in ODM system, please create and use a unique ID. Maximum 10 characters for Manufacturer_ID (no blanks, only capital letters). IDs used in Manufacturer template and in AVL template must match
S	Manufacturer_Name	Name of component manufacturer in ODM system with maximum 40 characters. Only one manufacturer per line
T	Order_Code	Order code (= <u>vendor part number</u> = <u>manufacturer part number</u>) of component . Only one order code per line
U	Order_Code_Release_Status	Release status of order code in ODM system. Please provide meaning of different release status used in a separate notice .
V	Validity_From	if component validity is limited: from when this component is being used
W	Validity_To	if component validity is limited: until when this component is being used
X	Distributor_ID	ID of the distributor in ODM system. If no distributor is used for that component (but direct supply from manufacturer), please leave the cell empty.
Y	Distributor_Name	Name of the distributor in ODM system. If no distributor is used for that component (but direct supply from manufacturer), please leave the cell empty.

2. Manufacturer/Distributor Template

Manufacturer : Producer of components
 Distributor : Distributor of components

All manufacturers and distributors mentioned in the AVL template must be listed in the manufacturer/distributor template.

Naming convention of the file to be returned to BSH:

Manufacturer_ **ODM_ID** _ **Export Date**.xls

Please change the following parts of the syntax:

ODM_ID

Export Date

IDs used in Manufacturer/Distributor template and in AVL template must match
F	ODM_Manufacturer_Distributor_Name	(Full) name of manufacturer/distributor, maximum 40 characters. No duplicate values
G	Country	Country where manufacturer/distributor is registered. Pls use 2-digit Country Code according to ISO 3166

I	City	City where manufacturer/distributor is registered
J	PO_Box	PO box of manufacturer/distributor
K	ZIP_Code	ZIP code of manufacturer/distributor address

TAX_No or VAT_No_EU or DUNS_No serve as identification of the manufacturer/distributor.

3. Additional Notes to Consider

AVL Template (Approved-Vendor-List)

1. If values in column **BSH_PCBA_SAP Material_Number** matches with **BSH_SAP_Material_Number**, **BSH_PCBA_SAP Material_Number (Column F)** is not required.
2. Please provide your own position numbers or for dummy **BOM_Pos_Number** please follow a 4-digit formatting starting from 0010 and incremented by 10, going up sequentially (e.g. "0010", "0020"). The same number used as a reference for alternative components.
3. The **Manufacturer_ID** and **Manufacturer_Name** cannot be empty. They must also match the IDs in the Manufacturer/Distributor Template.
4. The **ODM_Component_Name** column should not exceed 128 characters.
5. Unique values for **Manufacturer_ID** and **Distributor_ID** required. Wrong use of IDs are, the same ID for two more different companies and also different use of ID for the same company.
6. Manufacturers in the AVL must be present in the **Manufacturer/Distributor Template**. Please ensure that all manufacturers are included in the Manufacturer list, as sometimes some manufacturers may be missed and not included.
7. Please avoid leaving any fields blank for **Order_Code** and **Order_Code_Release_Status**. Additionally, do not use values like 0 or "Not Provided"
8. The accepted values for the **unit of measure (UoM)** are PC, PCS, KG, G, and M. If PC or PCS is used, the quantity must be an integer value. Values like 0.5 PC are not accepted.
9. Please ensure that the **CADREF** and **BOM_Pos_Number** are placed in their respective columns correctly. Do not interchange them.
10. The columns **Distributor_ID** or **Distributor_Name** should not contain "NA", "Not Provided", or "Not Sourced" values. If the information is not available, please leave the field empty.
11. Only use Latin alphabet characters. If there are any non-Latin characters, such as Chinese characters, please remove or change them to Latin characters before sending.

Manufacturer/Distributor Template

1. Please use the 2-digit Country Code according to ISO 3166 in column **Country**, such as "DE" for Germany, instead of country names.
2. Unique values for **Manufacturer_ID** and **Distributor_ID** required. Wrong use of IDs are, the same ID for two more different companies and also different use of ID for the same company.
3. Please avoid having duplicate companies in the Manufacturer List
4. The Manufacturer List should not contain "NA" or "Not Provided" values. If the information is not available, leave the field empty except **ODM_Manufacturer_Distributor_ID** and **ODM_Manufacturer_Distributor_Name**.
5. Only use Latin alphabet characters. If there are any non-Latin characters, such as Chinese characters, please remove or change them to Latin characters before sending.

The order code must be entered COMPLETELY. If there are several options available due to different packaging (e.g. reel size and type, or tray/box), the order code for the **largest** (plastic) reel/tube shall be used.
