Documents

In order to prevent any delays at the customs borders, DB Schenker Schweiz AG will prepare the customs clearance during the transit period. For this reason, it is essential that all required documents, for example:

- **Invoice** including the BSH order number / shipment number and the Incoterm (DAP mandatory)
- **Delivery note** (mandatory)
- Packing list (mandatory)
- **Customs Documents** such as European Export Document, T-Document, etc. (mandatory)

- House air way bill, B/L, railway consignment note
- Copy of EUR.1, Form A

must be sent to DB Schenker Schweiz AG by e-mail by 3pm on the day before at the latest.

Information: Certificates of origin, movement certificates

- EUR.1
- Form A or
- Invoices, delivery notes or other commercial documents with a declaration of origin must accompany the consignment

a) **without signature**, if **reference** is made to an **authorisation number** of the authorised exporter

b) **with original handwritten signature**, if **no reference** is made to an **authorisation number** of the authorised exporter.
